## ORDER

On August 6, 1993, the Commission received a letter from a customer of Southern Madison Water District ("Southern Madison") claiming that the charges proposed in Southern Madison's tariff are already being charged. A copy of the letter is attached hereto and incorporated herein as Appendix A. Attached to the letter was a cancelled check made payable to Southern Madison on July 6, 1993, for \$525. The customer was apparently charged a \$475 meter installation charge and a \$50 deposit charge. These charges are not the tariffed rates currently on file with the Commission. A copy of the check is attached hereto and incorporated herein as Appendix B.

Accordingly, the Commission finds that additional information is necessary.

IT IS THEREFORE ORDERED that:

 Within 10 days from the date of this Order, Southern Madison shall file the following:

a. A list of all bills sent out during the previous 6 months for meter installation and connection fee. Include the customer's name, address, date collected, and amount charged. A list of all deposits received during the previous 6 months. Include the customer's name, address, date collected, and amount collected.

c. A list of any other nonrecurring charge which Southern Madison has collected over the previous 6 months; include the customer's name, address, service provided, date service was provided, and amount charged.
