COMPLAINT

The complaint of Helen Reynolds respectfully shows:

- a) Helen Reynolds, unemployed, resides at 643 W. 12th Street, Covington, Kentucky 41011.
- b) The Defendant is the Union Light, Heat and Power Company, 107 Brent Spence Square, Covington, Kentucky 41011.
- c) (1) That Helen Reynolds filed a Chapter 7 Bankruptcy in the Eastern District of Kentucky at Covington, on May 24, 1993, Case No. 93-2-0595.
- (2) That Defendant Union Light, Heat and Power Company was listed as a creditor in Ms. Reynolds' bankruptcy petition.
- (3) That Union Light, Heat and Power has demanded that Ms. Reynolds pay a new security deposit in the amount of \$353.00.
- (4) That Union Light, Heat and Power Company has refused Ms. Reynolds' offer of partial payments on the \$353.00 security deposit.
- (5) That Union Light, Heat and Power Company has refused to accept the utility deposit guaranty offered by the Kentucky Housing Corporation pursuant to its Rental Deposits

Surety Program, said offer was communicated by Ms. Reynolds' attorney, Carl J. Melcher, to Mr. Wefer, ULHEP, on July 12, 1993.

(6) That said offers were in compliance with, and should have been accepted by Union Light, Heat and Power pursuant to 807 KAR 5:006, Section 7.

WHEREFORE, complainant Helen Reynolds asks:

- 1. That the PSC assume jurisdiction of this billing dispute and, pursuant to 807 Kar 5:006, Section 11, order Union Light, Heat and Power to maintain service to complainant during the pendency of this case;
- 2. That the PSC order Union Light, Heat and Power to accept the guaranty of the deposit made by the Kentucky Housing Corporation;
