O R D E R

This matter arising upon the letter of Mr. John Harper, filed on August 6, 1993, requesting intervention on behalf of Mrs. Elizabeth Sullivan and approximately 62 individuals named in a petition which is attached hereto as Appendix A, and it appearing to the Commission that Mrs. Sullivan and those named in the petition have a special interest which is not otherwise adequately represented, and that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceeding, and this Commission being otherwise sufficiently advised,

IT IS HEREBY ORDERED that:

1. The request by Mrs. Sullivan and those named in Appendix A to intervene is granted.

2. Those named in Appendix A, other than Mrs. Sullivan, shall be limited intervenors entitled to the full rights of a party at any hearing and shall be served with this Order, any subsequent

order setting a hearing in this matter, and the final order of the Commission deciding this matter. They shall not be served with filed testimony, exhibits, pleadings, correspondence and all other documents submitted by parties, nor shall they be certified as parties for the purposes of receiving service of any petition for rehearing or petition for judicial review.

3. Mrs. Sullivan shall be deemed to be the spokesperson for those named in Appendix A and she shall be served with filed testimony, exhibits, pleadings, correspondence and all other documents submitted by parties.

4. Should Mrs. Sullivan file documents of any kind with the Commission in the course of these proceedings, she shall also serve a copy of said documents on all other parties of record.
