O R D E R

On July 21, 1993, GE Capital Communications Corporation d/b/a GE Exchange ("GE Exchange") filed its application with the Commission seeking a Certificate of Public Convenience and Necessity to provide intrastate, long-distance telecommunications services as a reseller within the Commonwealth of Kentucky.

GE Exchange is a Georgia corporation proposing to resell the services of telecommunications providers certified in the Commonwealth of Kentucky. GE Exchange does not seek the authority to provide directory service or operator-assisted telecommunications services, as these services will be provided by the underlying carrier.

GE Exchange employs no transmission or reception telecommunications equipment or facilities in the performance of its services, and all networking will be provided by the underlying carrier. GE Exchange will not construct any new facilities in the Commonwealth of Kentucky.

The information provided by GE Exchange demonstrates its financial, managerial, and technical capability to provide

intrastate, long-distance telecommunications service. The proposed rates should be approved as the fair, just, and reasonable rates to be charged.

The Commission, having considered the application, the information provided by GE Exchange, and being otherwise sufficiently advised, HEREBY ORDERS that:

1. GE Exchange be and it hereby is granted authority to provide intrastate, long-distance telecommunications services within the Commonwealth of Kentucky on and after the date of this Order.

2. GE Exchange shall comply with the provisions of the Orders in Administrative Case No. 323.¹

3. GE Exchange's authority to provide service in this Commonwealth is strictly limited to those services described in this Order and GE Exchange's application.


4. The rates and charges proposed by GE Exchange are hereby approved, as filed on July 21, 1993, and amended on October 4, 1993.

5. Within 30 days from the date of this Order, GE Exchange shall file its revised tariff sheets in accordance with 807 KAR 5:011, and the restrictions and conditions of service contained herein as proposed in filings made July 21, 1993 and October 4, 1993.
