O R D E R

On August 10, 1993, Farmdale Water District ("Farmdale") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. Farmdale purchases water from the Frankfort Electric and Water Plant Board ("Frankfort").

2. Effective August 1, 1993, Frankfort will increase its rate for wholesale water from \$.98 per 1,000 gallons to \$1.03 per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, monthly bills to Farmdale customers will increase from \$13.30 to \$13.60, an increase of 2.26 percent.

3. Farmdale proposed to increase the rates to its customers effective August 1, 1993.

4. During the 12 months ending June 30, 1993, Farmdale purchased 179,997,900 gallons of water and sold 158,832,100 gallons.

5. Farmdale's calculations are correct and show an increase in purchased water cost of \$8,999.90, resulting in a purchased water adjustment of \$.06 per 1,000 gallons.

6. The purchased water adjustment of \$.06 cents per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of \$.06 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after August 1, 1993.


2. Farmdale's proposed tariff is approved as filed.


3. Within 30 days of the date of this Order, Farmdale shall file verification that the notice to its customers has been given.

The following rates and charges are prescribed for the customers in the area served by Farmdale Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.
