O R D E R

On August 9, 1993, Elkhorn Water District ("Elkhorn") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. Elkhorn purchases water from the Frankfort Electric and Water Plant Board ("Frankfort").

2. Effective August 1, 1993, Frankfort will increase its rate for wholesale water from \$.98 per 1,000 gallons to \$1.03 per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, monthly bills to Elkhorn customers will increase from \$19.51 to \$19.81, an increase of 1.54 percent.

3. Elkhorn proposed to increase the rates to its customers effective August 1, 1993.

4. During the 12 months ending July 31, 1993, Elkhorn purchased 40,117,100 gallons of water and sold 35,791,000 gallons.

5. Elkhorn's calculations are correct and show an increase in purchased water cost of \$2,006, resulting in a purchased water adjustment of \$.06 cents per 1,000 gallons.

6. The purchased water adjustment of \$.06 cents per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of \$.06 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after August 1, 1993.

2. Elkhorn's proposed tariff is approved.

3. Within 30 days of the date of this Order, Elkhorn shall file verification that the notice to its customers has been given.
