O R D E R

This matter arising upon petition of BellSouth Telecommunications, Inc., d/b/a South Central Bell Telephone Company ("South Central Bell") filed September 22, 1993 pursuant to 807 KAR 5:001, Section 7, for confidential protection of the cost support data developed in connection with a special service arrangement for the John Kenyon Eye Center for Call Forwarding Variable Multiple Simultaneous Calls associated with a 1A analog office on the grounds that disclosure of the information is likely to cause South Central Bell competitive injury, and it appearing to this Commission as follows:

South Central Bell has entered into a contract with the John Kenyon Eye Center for the provision of Call Forwarding Variable Multiple Simultaneous Calls. This service is currently tariffed but is available only in digital offices. The contract is for provision of the feature from a 1A analog office. In support of its application, South Central Bell has provided cost data which it seeks to protect as confidential.

Information sought to be protected is not known outside South Central Bell and is not disseminated within South Central Bell

except to those employees who have a legitimate business need to know and act upon the information. South Central Bell seeks to preserve and protect the confidentiality of the information through all appropriate means.

KRS 61.872(1) requires information filed with the Commission to be available for public inspection unless specifically exempted by statute. Exemptions from this requirement are provided in KRS 61.878(1). That section of the statute exempts 11 categories of information. One category exempted in subparagraph (c) of that section is commercial information confidentially disclosed to the Commission. To qualify for that exemption, it must be established that disclosure of the information is likely to cause substantial competitive harm to the party from whom the information was obtained. To satisfy this test, the party claiming confidentiality must demonstrate actual competition and a likelihood of substantial competitive injury if the information is disclosed. Competitive injury occurs when disclosure of the information gives competitors an unfair business advantage.

South Central Bell's competitors for call forwarding services are providers of customer premises equipment and PBX systems. Disclosure of the cost information sought to be protected would allow providers of such equipment to determine South Central Bell's cost and contribution from the service which competitors could use to market their competing services to the detriment of South Central Bell. Therefore, disclosure of the information is likely


to cause South Central Bell competitive injury and the information should be protected as confidential.

This Commission being otherwise sufficiently advised,


IT IS ORDERED that the cost support data developed by South Central Bell in connection with the special service arrangement contract with the John Kenyon Eye Center, which South Central Bell has petitioned be withheld from public disclosure, shall be held and retained by this Commission as confidential and shall not be open for public inspection.
