ORDER

On December 27, 1993, Goshen Utilities, Inc. ("Goshen") filed its application for Commission approval of proposed sewer rates. The application was considered filed on February 7, 1994, when all deficiencies were cured. The proposed rates would generate additional annual revenues of \$133,389.

On March 1, 1994, Commission Staff began a field review of Goshen's test period financial records. Based upon this review, Commission Staff issued a Staff Report on June 17, 1994, recommending that Goshen be allowed to increase its annual operating revenues from sewer service sales by \$48,671.

By Order dated June 17, 1994, the Commission advised Goshen that comments on the Staff Report or requests for a public hearing must be submitted no later than July 2, 1994. On June 29, 1994, Goshen filed comments accepting the Staff Report recommendations and did not request a hearing.

The Commission, after consideration of the evidence of record and being sufficiently advised, finds that:

1. The recommendations and findings contained in the Staff
Report are supported by the evidence of record, are reasonable, and
are hereby adopted as the findings of the Commission in this

proceeding and are incorporated by reference as if fully set out herein.

2. The rates in Appendix A, which is attached hereto and incorporated herein, are the fair, just, and reasonable rates for Goshen and will produce gross annual revenues of \$244,822 from sewer service sales. These rates will allow Goshen sufficient revenues to meet its operating expenses and service its debt.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Staff and contained in Appendix A are approved for service rendered by Goshen on and after the date of this Order.
- 2. Within 30 days of the date of this Order, Goshen shall file with the Commission its revised tariff setting out the rates approved herein.
