ORDER

On April 22, 1994, First American Network, Inc. ("First American") submitted its application with the Commission seeking a Certificate of Public Convenience and Necessity to provide intrastate, long-distance telecommunications services as a reseller within the Commonwealth of Kentucky.

First American is an Ohio corporation proposing to resell the services of carriers currently certified within the Commonwealth of Kentucky in accordance with the terms and conditions set forth in its tariff. First American is not seeking authority to provide operator-assisted telecommunications services.

First American employs no transmission or reception telecommunications equipment or facilities in the performance of its services, and all facilities, equipment, and networking will be provided by the underlying carrier. First American will not construct any new facilities in the Commonwealth of Kentucky.

The information provided by First American demonstrates its financial, managerial, and technical capability to provide

intrastate, long-distance telecommunications service. The proposed rates as submitted April 22, 1994 should be approved as the fair, just, and reasonable rates to be charged.

The Commission finds that First American's request for an exemption from maintaining its records in accordance with the Uniform System of Accounts is moot. The Commission has previously exempted all non-dominant carriers from this requirement.

The Commission, having considered the application, the information provided by First American, and being otherwise sufficiently advised, HEREBY ORDERS that:

- 1. First American be and it hereby is granted authority to provide intrastate, long-distance telecommunications services within the Commonwealth of Kentucky on and after the date of this Order.
- 2. First American shall comply with the provisions of the Orders in Administrative Case No. 323.
- 3. First American's authority to provide service in this Commonwealth is strictly limited to those services described in this Order and First American's application.
- 4. The rates and charges proposed by First American are hereby approved as submitted on April 22, 1994.

5. Within 30 days from the date of this Order, First American shall file its tariff sheets in accordance with 807 KAR 5:011.
