ORDER

On July 29, 1994, Jessamine County Water District No. 1 ("Jessamine County") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. (KRS 278.015 and 807 KAR 5:068.)

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. Jessamine County purchases water from the city of Nicholasville ("Nicholasville").
- 2. Nicholasville increased its rates for water sold from \$1.43 per 1,000 gallons to \$1.49 per 1,000 gallons effective July 11, 1994.
- 3. Jessamine County proposed to increase the water rates to its customers effective July 13, 1994.
- 4. During the 12 months ending June 30, 1994, Jessamine County purchased 91,774,990 gallons of water and sold 83,382,894 gallons.
- 5. Jessamine County's calculations are correct and show an increase in purchased water cost of \$5,506.50, resulting in a

purchased water adjustment of 6 cents per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, the average bill of Jessamine County's customers would increase 30 cents from \$19.55 to \$19.85 or 2 percent.

6. The purchased water adjustment of 6 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of 6 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after July 13, 1994.
 - 2. Jessamine County's proposed tariff is approved.
- 3. Within 30 days of the date of this Order, Jessamine County shall file verification that the notice to its customers has been given.

The following rates and charges are prescribed for the customers in the area served by Jessamine County Water District No.

1. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Monthly Rates:

Minimum Bills:

5/8" x 3/4" Meter 3,000 gallon minimum	usage	\$14.25
1" Meter 5,000 gallon minimum	usage	19.85
1-1/2" Meter 10,000 gallon minimum	usage	33.85

All usage above the minimum will be billed according to the rate schedule.
