O R D E R

On September 19, 1994, Jessamine County Water District No. 1 ("Jessamine No. 1") filed an application with the Public Service Commission ("Commission") requesting authority to increase its 5/8 X 3/4 inch service connection fee from \$375 to \$500, its 1 inch service connection fee from \$600 to \$675, its 1-1/2 inch service connection fee from \$900 to \$1,000, and to establish a 2 inch service connection fee of \$1,250. With its application, Jessamine No. 1 provided cost justification for each fee consisting of meter installation from Stephenson Construction Company, cost of the meter itself, and administrative costs of \$40 per service connection.

Given that details of the average administrative cost for meter installations must be provided in order to conduct an adequate review, the Commission required Jessamine No. 1 to provide a breakdown of the administrative costs involved in providing service connections to its customers.

In response to the Commission's October 14, 1994 Order, Jessamine No. 1 did not provide adequate information to justify approval of the \$40 administrative expense component. Jessamine

No. 1, however, did provide in its initial application information sufficient to justify approval of the fees to include only the actual cost of the meter and installation by Stephenson Construction Company.

IT IS THEREFORE ORDERED that:

1. Jessamine No. 1's proposed service connection fees be and they hereby are denied.


2. Jessamine No. 1's service connection fees shall include only the actual cost of meters and the cost of installation by Stephenson Construction Company as filed in the original application. The service connection fees set out in Appendix A shall be effective for services initiated on and after the date of this Order.

3. Within 30 days of the date of this Order, Jessamine No. 1 shall file its revised tariff setting out the rates approved herein.
