O R D E R

On April 24, 1991, in Case No. 91-004, the Commission approved adjustments to the rates of Johnson County Gas Company, Inc. ("Johnson County") on a quarterly basis in accordance with the Gas Cost Adjustment ("GCA") Clause set forth in the Order.

On June 14, 1995, Johnson County filed its GCA to become effective from July 1, 1995 to October 1, 1995.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Johnson County's notice of June 4, 1995 proposed revised rates designed to pass on its increased wholesale gas costs to its customers. Johnson County's expected gas cost ("EGC") is \$2.9085 per Mcf.
2. Johnson County's notice set out no refund adjustment.
3. Johnson County's notice set out a current quarter actual adjustment ("AA") of 10.25 cents per Mcf, which should have been (10.25) cents per Mcf, to return overrecovered gas cost from January, February, and March 1995. The proposed total AA of (16.05) cents per Mcf reflects the current over-recovery as well as under- and over-recoveries from previous quarters.

4. Johnson County's notice set out a current quarter balance adjustment ("BA") of (.80) cent per Mcf. Johnson County's total BA of (.50) cent per Mcf reflects the current and three previous quarters' BAs.

5. These adjustments produce a gas cost recovery rate of \$2.7430 per Mcf, 1.4 cents per Mcf less than the prior rate.

6. The rate adjustment in the Appendix to this Order is fair, just, and reasonable, in the public interest, and should be approved for service rendered on and after the date of this Order.

IT IS THEREFORE ORDERED that:


1. The rates proposed by Johnson County are hereby denied.


2. The rates in the Appendix to this Order are fair, just, and reasonable, and are effective for service rendered on and after the date of this Order.

3. Within 30 days of the date of this Order, Johnson County shall file with this Commission its revised tariffs setting out the rates authorized herein.


