ORDER

On December 17, 1993, in Case No. 93-400, the Commission approved the merger of Elzie Neeley Gas Company, Inc. ("Elzie Neeley") and Phelps Gas Company, Inc. ("Phelps") into Mike Little Gas Company, Inc. ("Mike Little") and provided for the adjustment of rates of the merged companies on a quarterly basis in accordance with the provisions of Mike Little's gas cost adjustment ("GCA") clause.

On September 29, 1995, Mike Little filed its GCA to be effective November 1, 1995 until January 31, 1996.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Mike Little's notice proposed revised rates designed to pass on its expected wholesale decrease in gas cost to its customers. Mike Little's expected gas cost ("EGC") for the quarter is \$3.6761 per Mcf.
 - Mike Little's notice set out no refund adjustment.
- 3. Mike Little's notice set out a current quarter actual adjustment ("AA") of .09 cent per Mcf to collect under-recovered gas cost from May, June, and July 1995. The total AA of 1.47 cents

per Mcf reflects the net under-recovery of the combined system for the current and previous three quarters.

- 4. These adjustments produce a gas cost recovery rate ("GCR") of \$3.6908 per Mcf, 5.42 cents per Mcf less than the prior rate.
- 5. The rate adjustments in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be effective for gas supplied on and after November 1, 1995.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable, and are effective for gas supplied on and after November 1, 1995.
- 2. Within 30 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized in this Order.
- 3. In its April 1, 1996 filing for rates effective May 1, 1996, Mike Little shall include a report of additional customers receiving service on the new Joint Venture supply line, along with a comparison of the IUS rate to other available rates.
