O R D E R

On November 1, 1994, in Case No. 94-179, the Commission approved certain adjusted rates for Columbia Gas of Kentucky, Inc. ("Columbia") and provided for their further adjustment on a quarterly basis in accordance with its gas cost adjustment ("GCA") clause.

On November 1, 1995, Columbia filed its GCA to be effective December 1, 1995 through February 29, 1996.

After reviewing the record and being otherwise sufficiently advised, the Commission finds that:

1. Columbia's notice proposed revised rates designed to pass on its expected wholesale increase in gas costs. Columbia's proposed expected gas cost ("EGC") for the quarter beginning December 1, 1995 is \$3.5495.

2. Columbia's notice set out a rate for Banking and Balancing Service of 2.38 cents per Mcf.

3. Columbia's notice set out total fixed charge refund adjustments of 0 cent per Mcf for sales and transportation customers.

4. Columbia's notice set out its approved actual cost adjustment ("ACA") of (63.30) cents per Mcf.

5. Columbia's notice set out its approved balancing adjustment ("BA") of (6.64) cents per Mcf.

6. Columbia's notice contained no current refund adjustment. The total refund adjustment of 6.56 cents per Mcf reflects previous quarter refund adjustments.

7. Columbia's notice set out a Special Agency Service refund adjustment of .05 cent per Mcf.

8. These adjustments produce a gas cost recovery rate ("GCR") of \$2.7840, 5.18 cents per Mcf more than the prior rate.

9. The revised rate adjustments in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for gas supplied on and after December 1, 1995.


IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable, and are effective for gas supplied on and after December 1, 1995.

2. Within 30 days of the date of this Order, Columbia shall file with this Commission its revised tariffs setting out the rates authorized in this Order.
