ORDER

On November 17, 1994, Touchtone Network, Inc. ("Touchtone Network") filed an application with the Commission seeking a Certificate of Public Convenience and Necessity to resell intrastate long-distance telecommunications services within the Commonwealth of Kentucky. On February 17, 1995, Touchtone Network filed its response to the Commission's January 30, 1995 Order requesting additional information.

Touchtone Network is a Florida corporation with its principal offices in the state of Florida and intends to resell tariffed services of facilities-based carriers certified by this Commission. Touchtone Network does not request authority to provide operatorassisted telecommunications services.

Touchtone Network does not own or operate, nor does it intend to construct, any telecommunications transmission facilities within the Commonwealth of Kentucky. All intrastate telecommunications transmission services will be provided by an underlying carrier certified by this Commission.

The application provided by Touchtone Network demonstrates its financial, managerial, and technical capability to provide utility

service. The Commission finds that Touchtone Network should be authorized to resell intrastate long-distance telecommunications services within the Commonwealth of Kentucky.

Touchtone Network filed its proposed tariff on November 17, 1994. In response to the Commission's request for additional information, Touchtone Network filed revised tariff sheets on February 17, 1995. The Commission finds that the rates proposed by Touchtone Network, as revised on February 17, 1995, should be approved as the fair, just, and reasonable rates to be charged.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, HEREBY ORDERS that:

1. Touchtone Network be and it hereby is granted authority to resell intrastate long-distance telecommunications services within the Commonwealth of Kentucky on and after the date of this Order.

2. Touchtone Network's authority to provide service is strictly limited to those services described in this Order and Touchtone Network's application.

3. IntraLATA services shall be provided in accordance with the restrictions and conditions of service contained in Administrative Case No. 323.¹

4. The rates proposed by Touchtone Network on November 17, 1994, as revised on February 17, 1995, are hereby approved.

5. Within 30 days from the date of this Order, Touchtone Network shall file, pursuant to 807 KAR 5:011, its November 17, 1994 tariff sheets, as revised on February 17, 1995, without modifications and which conform to the restrictions and conditions of service contained herein.
