## ORDER

Bracken County Water District No. 1 ("Bracken District") has requested that the Commission amend its Order of July 3, 1995 to amend the effective date of the proposed increase to its General Service Connection charge and its proposed Deposit Charge to November 1, 1995. Bracken District states that assessing these charges before November 1, 1995 will undermine a major waterline extension project. It has assured subscribers to this project that connection charges would not exceed \$350. Bracken District fears that the increased connection charge and the new deposit charge will cause project subscribers to withdraw.

Having considered the motion and being otherwise sufficiently advised, the Commission finds that Bracken District's Motion to Amend the July 3, 1995 Order should be granted.

#### IT IS THEREFORE ORDERED that:

- 1. Bracken District's Motion to Amend is granted.
- 2. The Ordering Paragraphs of the July 3, 1995 Order are stricken and replaced with the following:

On August 16, 1995, Bracken County Water District No. 1 notified the Commission that its name had officially changed to Bracken County Water District.

- 1. The charges in Appendix A are approved for services rendered on and after July 3, 1995.
- 2. The charges in Appendix B are approved for services rendered on and after November 1, 1995.
- 3. Bracken District shall file with the Commission revised tariff sheets reflecting the charges set forth in Appendix A no later than October 1, 1995.
- 4. Bracken District shall file with the Commission revised tariff sheets reflecting the charges set forth in Appendix B no later than November 15, 1995.
- 3. Appendix A to the Order of July 3, 1995 is stricken and replaced with Appendices A and B to this Order.
