As owners of the St. Denis Shopping Center, my brother and I, along with other business owners and the Fiscal Court have worked hard to improve the image of the Cane Run Road area. The Fiscal Court spending more than one hundred thousand dollars planting trees and shrubs.

The Planning and Zoning Commission have zoned the area along Cane Run Road C-1 Commercial, with the exception of a few small parcels that are zoned C-2 Commercial.

The St. Denis Shopping Center is within a 500 foot radius of 4316 Cane Run Road, where Kentucky CGSA Inc. has applied for a Certificate of Public Convenience and Necessity to construct and operate a new facility to provide cellular radio telecommunication service.

We feel this facility with tower and equipment shelter would be a detriment to this area and we oppose the proposed construction.
