O R D E R

On October 4, 1995, Elkhorn Water District ("Elkhorn") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. Elkhorn purchases water from the Frankfort Electric and Water Plant Board ("Frankfort").

2. Effective October 26, 1995, Frankfort increased its rate for wholesale water from \$1.08 per 1,000 gallons to \$1.13 per 1,000 gallons.

3. Elkhorn proposed to increase the rates to its customers effective October 26, 1995.

4. During the 12 months ending September 30, 1995, Elkhorn purchased 50,268,600 gallons of water and sold 48,552,000 gallons.

5. Elkhorn's calculations are correct and show an increase in purchased water cost of \$2,513.43, resulting in a purchased water adjustment of 5 cents per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, the average bill of Elkhorn's

customers would increase 25 cents from \$20.11 to \$20.36, or 1.24 percent.

6. The purchased water adjustment of 5 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of 5 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after October 26, 1995.

2. Elkhorn's proposed tariff is approved.


3. Within 30 days of the date of this Order, Elkhorn shall file verification that the notice to its customers has been given.

APPENDIX A

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 95-443 DATED NOVEMBER 3, 1995.

The following rates and charges are prescribed for the customers in the area served by Elkhorn Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

GENERAL SERVICE

Monthly Rates:

First	2,000 gallons	\$ 9.74	Minimum Bill
Next	3,000 gallons	3.54	per 1,000 gallons
Next	5,000 gallons	3.07	per 1,000 gallons
Over	10,000 gallons	2.07	per 1,000 gallons

MINIMUM BILLS

General Service Meters:

5/8"	2,000 gallons	\$ 9.74
1"	5,000 gallons	20.36
1-1/2"	10,000 gallons	35.71
2"	16,000 gallons	48.13

All usage in excess of the minimum shall be billed according to the General Rate Schedule.

Mobile Home Parks:

McConnell	15,000 gallons	\$ 73.05
Elkhorn	76,000 gallons	370.12
Capital	125,000 gallons	608.75

Minimum for mobile home parks is determined by multiplying the number of spaces available by one-half the minimum usage allowance and minimum bill for general service. All usage in excess of the minimum is billed at general service rates.
