Dear Ms Curtis;

During our telephone conversation on 4/5/95 I mentioned I was currently doing a physical inventory of Kentucky State University's (KSU) telephone system. The three main numbers above have a total of nine lines all of which were found with NO Bell demarcation (RJ) point. I was able to trace the dial tone for the lines up to a telephone closet on the third floor of the J. Carroll building (room 323 closet 322). The lines are on house blocks no longer used for live lines. I am asking that Bell show KSU where these lines are working on a verified Bell demarcation point.

I have listed some of my findings that may help in your investigation. Mr. Mike Fitzpatrick, the full time ROLM technician, has confirmed my findings. If you have any questions or would like to discuss anything please feel free to contact me at 908-727-1726. Thank you for your time and cooperation..

- 1) All nine lines show installed around 12/83 and are ring no answer
- 2) Five of the lines are billed for CBT05's, obsolete data interfaces, which have not been used by KSU since 1987, per Ray W. manager of the KSU data center.
- 3) A search of the data center (even the raised floor area) found no trace of these lines. Ray W. confirmed these lines not working on any equipment since he has been there (1987).
- 4) ROLM has been in charge of all on campus telecommunications since they put in their system 1984 and all in house wiring. NO records of these numbers exist.
- 5) KSU comptroller, Ms Black has no records of these numbers.

CENY

The factors that point to these lines not working for KSU longer than the one year period of time are:

- a) all lines went in 12/30/83 so it appears they were being used for the same purpose, and all lines were found on the original abandoned Bell cable going to the third floor.
- b) five of the nine have CBT's billed to them (obsolete data interfaces) and not used by KSU since 1987.
- c) no activity on any of the accounts since at least 1992 per South Central Bell's own records, that was only to add those to a summary bill.
- d) no, RJ or CBT's were found and no house wire other than Belis old original cables were found on these lines.
- e) Bell technicians were the only ones to work on the original cables all working lines were put on RJ-21X's for ROLM to connect in house.

I am asking that the Public Service Commission look into a decision made by South Central Bell to issue credit for only one year. The credit is related to nine lines (see attached CSR's) that were not found working on any demarcation point or at any customer equipment, by South Central Bell's technician.

I have placed all of the facts in sequential order so that it will be easier to follow.

- 1) the original inquiry was sent to Ms Evvy Curtis of South Central Bell on April 10,1995 (see the attached letter).
- 2) during my tolephone conversations with Ms Curtis I learned that these accounts had no activity for many years. In fact the last account to show any activity was 502-223-4464 and that was on 6/04/92, when this and all other accounts were summary billed.
- 3) on 4/25/95 it was decided that a Bell technician would do a physical inventory.
- 4) my call to Ms Curtis on May 2,1995, found that the technician had gone out and could not find any of the nine lines on a demarcation point nor could he find any trace of them working (five of the lines are still being billed for CBT02/05's). At that time Ms Curtis informed me that she had talked to Ms Sharon Black, comptroller of KSU, and that she had agreed to a one year credit. Ms Curtis also informed me that it was policy for only six months credit to be given in these situations.
- 5) On 5/03/95 Ms Black informed me that she was under the impression that only six months was what Bell was required to give credit for, and that the one year given was extra.
- 6) A twelve month credit appeared on the May 04,1995 main bill for all nine lines.

The factors that point to these lines not working for KSU longer than the one year period of time are:

- a) all lines went in 12/30/83 so it appears they were being used for the same purpose, and all lines were found on the original abandoned Bell cable going to the third floor.
- b) five of the nine have CBT's billed to them (obsolete data interfaces) and not used by KSU since 1987.
- c) no activity on any of the accounts since at least 1992 per South Central Bell's own records, that was only to add these to a summary bill.
- d) no, RJ or CBT's were found and no house wire other than Bells old original cables were found on these lines.
- e) Bell technicians were the only ones to work on the original cables altworking lines were put on RJ-21X's for ROLM to connect in house.
