ORDER

On April 24, 1991, in Case No. 91-004, the Commission approved adjustments to the rates of Johnson County Gas Company, Inc. ("Johnson County") on a quarterly basis in accordance with the Gas Cost Adjustment ("GCA") Clause set forth in the Order.

On May 31, 1996, Johnson County filed its GCA to become effective from July 1, 1996 to October 1, 1996.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Johnson County's notice of May 31, 1996 proposed rates designed to pass on its decreased wholesale gas costs to its customers. Johnson County's expected gas cost ("EGC") is \$4.0380 per Mcf.
- 2. Johnson County's notice set out no refund adjustment. It neglected to reflect a refund adjustment of 1.9 cents per Mcf to return refunds from a previous quarter. The total refund adjustment should be 1.9 cents per Mcf.
- 3. Johnson County's notice set out a current quarter actual adjustment ("AA") of 84.2 cents per Mcf to collect under-recovered gas cost from January, February, and

March 1996. The proposed total AA of 95.9 cents per Mcf reflects the current underrecovery as well as under- and over-recoveries from previous quarters.

- 4. Johnson County's notice set out a current quarter balance adjustment ("BA") of (.45) cent per Mcf. Johnson County's total BA of .65 cent per Mcf reflects the current and three previous quarters' BAs.
- 5. These adjustments produce a gas cost recovery rate of \$4.9845 per Mcf, 16.35 cents per Mcf more than the prior rate.
- 6. The corrected rate adjustment in the Appendix to this Order is fair, just, and reasonable, in the public interest, and should be approved for service rendered on and after July 1, 1996.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Johnson County are hereby denied.
- 2. The rates in the Appendix to this Order are fair, just, and reasonable, and are effective for service rendered on and after July 1, 1996.
- 3. Within 30 days of the date of this Order, Johnson County shall file with this Commission its revised tariffs setting out the rates authorized herein.
