### ORDER

On September 30, 1991 in Case No. 90-402, the Commission approved certain adjusted rates for Martin Gas, Inc. ("Martin") and provided for their further adjustment when the wholesale cost of gas changes or a refund is received.

On July 29, 1996, Martin filed for approval to pass its increased wholesale gas cost from Columbia Gas of Kentucky, Inc. ("Columbia"), to its customers effective June 1, 1996.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Martin's notice proposed revised rates designed to pass to its customers

  Columbia's Intrastate Utility Service ("IUS") rate effective June 1, 1996.
- 2. The Commission approved Columbia's IUS rate of \$3.5366 per Mcf effective June 1, 1996. However, on August 6, 1996, Columbia filed proposed rates to be effective September 1, 1996, which have been subsequently approved by the Commission.<sup>1</sup> Because the June 1, 1996 rate was an increase, Martin would not be able to pass along

its own increase in rates proposed in this filing until August 28, 1996 due to the 30-day notice requirement in KRS 278.180. By operation of law, the September 1, 1996 IUS rate of \$4.6931 per Mcf would then supersede the rate for June 1, 1996. The rates for Martin should, therefore, be recalculated to reflect the \$4.6931 per Mcf IUS rate and placed into effect September 1, 1996.

3. The rate adjustment in the Appendix, attached hereto and incorporated herein, is fair, just, and reasonable, in the public interest, and should be approved effective on and after September 1, 1996.

#### IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Martin are hereby denied.
- 2. The rates in the Appendix are fair, just, and reasonable and are approved effective for gas supplied on and after September 1, 1996.
- 3. Within 30 days of the date of this Order, Martin shall file with this Commission its revised tariffs setting out the rates authorized herein.

## APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 90-402-R DATED AUGUST 28, 1996

The following rates and charges are prescribed for the customers in the area served by Martin Gas, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

### RATES: Monthly

First 1 Mcf Over 1 Mcf \$8.1002 Per Mcf 7.9834 Per Mcf

### Minimum Bill
