O R D E R

On November 1, 1994, in Case No. 94-179, the Commission approved certain adjusted rates for Columbia Gas of Kentucky, Inc. ("Columbia") and provided for their further adjustment on a quarterly basis in accordance with its gas cost adjustment ("GCA") clause.

On October 30, 1996, Columbia filed its GCA to be effective December 1, 1996 through February 28, 1997.

After reviewing the record and being otherwise sufficiently advised, the Commission finds that:

1. Columbia's notice proposed revised rates designed to pass on its expected wholesale increase in gas costs. Columbia's proposed expected gas cost ("EGC") for the quarter beginning December 1, 1996 is \$4.1554.

2. Columbia's notice set out a rate for Banking and Balancing Service of 2.24 cents per Mcf.

3. Columbia's notice set out a take-or-pay refund adjustment of 12.25 cents per Mcf.

4. Columbia's notice set out a transportation take-or-pay refund adjustment of 4.36 cents per Mcf.

5. Columbia's notice set out its actual cost adjustment ("ACA") of 51.48 cents per Mcf.

6. Columbia's notice set out a balancing adjustment ("BA") of .81 cent per Mcf.

7. Columbia's notice contained a current refund adjustment of .19 cent per Mcf to return supplier refunds of \$39,207, including interest, to its customers. The total refund adjustment of 7.78 cents per Mcf reflects the current as well as previous quarter refund adjustments.

8. Columbia's notice set out a Special Agency Service refund adjustment of .03 cent per Mcf.

9. These adjustments produce a gas cost recovery rate ("GCR") of \$4.4777, 7.58 cents per Mcf more than the prior rate.

10. The revised rate adjustments in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for gas supplied on and after December 1, 1996.


IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order are fair, just, and reasonable, and are effective for gas supplied on and after December 1, 1996.


2. Within 30 days of the date of this Order, Columbia shall file with this Commission its revised tariffs setting out the rates authorized in this Order.
