ORDER

Pursuant to Commission Regulation 807 KAR 5:056, Section 1(11), IT IS HEREBY ORDERED that:

- 1. East Kentucky Power Cooperative, Inc. ("East Kentucky") shall appear at the Commission's offices in Frankfort, Kentucky, on August 22, 1996 at 9:00 a.m., Eastern Daylight Time, to submit itself to examination on the application of its fuel adjustment clause ("FAC") from November 1, 1995 to April 30, 1996.
- 2. East Kentucky shall notify its customers in writing of the date, time, place, and purpose of the hearing or shall publish such notice in accordance with 807 KAR 5:011, Section 8(5).
- 3. East Kentucky shall, on or before July 12, 1996, file with the Commission an original and 6 copies of the information requested in Appendix A, attached hereto and incorporated herein. Each copy shall be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed; for example, Item 1(a), Sheet 2 of 6. East Kentucky shall furnish

with each response the name of the witness who will be available at the public hearing to respond to questions concerning each area of information requested. Careful attention shall be given to copied material to ensure its legibility.

4. The records of Cases No. 94-459,¹ No. 94-459-A,² and 94-459-B,³ East Kentucky's monthly FAC filings, and all other materials which East Kentucky filed with the Commission pursuant to 807 KAR 5:056 for the period from November 1, 1995 to April 30, 1996 are incorporated by reference into the record of this proceeding.

APPENDIX A

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 94-459-C DATED JUNE 13, 1996

- 1. List each written coal supply solicitation issued during the period from November 1, 1995 to April 30, 1996.
- a. For each, provide the date of the solicitation, the type of solicitation (contract or spot), the quantities solicited, a general description of the quality of coal solicited, the time period over which deliveries were requested, and the generating unit(s) for which the coal was intended.
- b. For each, state the number of vendors to which the solicitation was sent, the number of vendors which responded, and the selected vendor. Provide the bid tabulation sheet or corresponding document which ranked the proposals. (This document should identify all vendors which made offers.) Briefly discuss the reasons for each selection.
- 2. List each oral coal supply solicitation issued during the period from November 1, 1995 to April 30, 1996.
- a. For each, provide a brief explanation of why the solicitation was not written, the date(s) of the solicitation, the quantities solicited, a general description of the quality of coal solicited, the time period over which deliveries were requested, and the generating unit(s) for which the coal was intended.
- b. For each, identify all vendors solicited and the vendor selected.

 Provide the tabulation sheet or other document which ranked the proposals. (This

document should identify all vendors who made offers.) Briefly discuss the reasons for each selection.

- 3. For the period from November 1, 1995 to April 30, 1996:
- a. List each vendor from which coal was purchased and the quantities and the nature of each purchase (e.g., spot or contract).
- b. State the number of solicitations issued to each vendor listed in part (a), identified as contract or spot solicitations, and the number of proposals made by each vendor in response to the solicitations.
- 4. For each generating station or unit for which a separate coal pile is maintained, state for the period from November 1, 1995 to April 30, 1996 the actual amount of coal burned in tons, actual amount of coal deliveries in tons, total KWH generated, and actual capacity factor at which the plant operated.
- 5. List all firm power commitments for East Kentucky from November 1, 1995 to April 30, 1996 for (a) purchases and (b) sales. This list shall identify the electric utility, the amount of commitment in MW and the purpose of the commitment (e.g., peaking, emergency).
- 6. Provide a monthly billing summary for sales to all electric utilities for the period November 1, 1995 through April 30, 1996.
- 7. List East Kentucky's scheduled, actual, and forced outages between November 1, 1995 and April 30, 1996.

- 8. List all existing fuel contracts categorized as long-term (i.e., more than 1 year in length). Provide the following information for each contract:
 - a. Supplier's name and address;
 - b. Name and location of production facility;
 - c. Date when contract executed;
 - d. Duration of contract;
 - e. Date(s) of each contract revision, modification or amendment;
 - f. Annual tonnage requirements;
 - g. Actual annual tonnage received since the contract's inception;
 - h. Percent of annual requirements received during the contract's term;
 - i. Base price;
 - j. Total amount of price escalations to date;
 - k. Current price paid for coal under the contract $(i \div j)$.
- 9. a. Does East Kentucky regularly compare the price of its coal purchases with those paid by other electric utilities?
 - b. If yes, state:
- (1) how East Kentucky's prices compare with those of other utilities for the period under review.
- (2) the utilities which are included in this comparison and their location.

- 10. What percentage of East Kentucky's coal, as of the date of this Order, is delivered by:
 - a. barge?
 - b. rail?
 - c. truck?
- 11. a. State East Kentucky's coal inventory level in tons and in number of day's supply as of April 30, 1996.
 - b. Describe the criteria used to determine number of days supply.
- c. Compare East Kentucky's coal inventory as of April 30, 1996 to its inventory target for that date.
- d. If actual coal inventory exceeds inventory target by 10 days' supply,
 state the reasons for excessive inventory.
- e. (1) Does East Kentucky expect any significant changes in its current coal inventory target within the next 12 months?
- (2) If yes, state the expected change and the reasons for this change.
- 12. a. Has East Kentucky audited any of its coal contracts during the period from November 1, 1995 to April 30, 1996?
 - b. If yes, for each audited contract:
 - (1) Identify the contract.
 - (2) Identify the auditor.
 - (3) State the results of the audit.

- (4) Describe the actions which East Kentucky took as a result of the audit.
- 13. a. Has East Kentucky received any customer complaints regarding its fuel adjustment clause during the period from November 1, 1995 to April 30, 1996?
 - b. If yes, for each complaint, state:
 - (1) The nature of the complaint.
 - (2) East Kentucky's response.
- 14. a. Is East Kentucky currently involved in any litigation with its current or former coal suppliers?
 - b. If yes, for each litigation:
 - (1) Identify the coal supplier.
 - (2) Identify the coal contract involved.
 - (3) State the potential liability or recovery to East Kentucky.
 - (4) List the issues presented.
- (5) Provide a copy of the complaint or other legal pleading which initiated the litigation, if not previously filed with the Commission.
 - c. State the current status of all litigation with coal suppliers.
- 15. a. During the period from November 1, 1995 to April 30, 1996, have there been any changes to East Kentucky's written policies and procedures regarding its fuel procurement?
 - b. If yes,
 - (1) What were these changes?

- (2) Provide these written policies and procedures as changed.
- (3) When were these changes made?
- (4) Why were they made?
- 16. a. Is East Kentucky aware of any violations of its policies and procedures regarding fuel procurement which occurred prior to or during the period from November 1, 1995 to April 30, 1996?
 - b. If yes, for each violation:
 - (1) Describe the violation.
- (2) Describe action which East Kentucky took upon discovering the violation.
 - (3) Identify the person(s) who committed the violation.
- 17. Identify all changes in the organizational structure and personnel of the departments or divisions which are responsible for East Kentucky's fuel procurement activities which occurred during the period from November 1, 1995 to April 30, 1996.
- 18. a. Identify all changes which East Kentucky has made during the period under review to its maintenance and operation practices and which affect fuel usage at East Kentucky's generation facilities.
 - b. Describe the impact of these changes on East Kentucky's fuel usage.
- 19. a. Prior to May 12, 1995, what was the expected in-service date for the Smith Station combustion turbines?
- b. When does East Kentucky now expect to place the Smith Station combustion turbines in service?

- c. What is the current status of the Smith Station combustion turbines?
- 20. a. (1) What efforts, if any, has East Kentucky taken to recover from ABB Power the cost of replacement power purchased as a result of the non-availability of the Smith Station combustion turbines?
 - (2) What is the result of these efforts?
- (3) Provide all correspondence, internal memoranda and any other documents which discuss the Smith Station combustion turbine blade failure and recovery of replacement power costs.
- b. What efforts, aside from those involving ABB Power, has East Kentucky taken to recover the cost of replacement power purchased as a result of the non-availability of the Smith Station combustion turbines?
- 21. a. During the period under review, did East Kentucky purchase replacement power because the Smith Station combustion turbines were unavailable?
- b. If yes, provide a summary of replacement power costs for the review period in the same format used in "East Kentucky's response to Commission Staff question concerning cost of replacement power for combustion turbine," which East Kentucky filed in Case No. 94-459-B on March 8, 1996.
