<u>O R D E R</u>

IT IS ORDERED that Intermedia Communications of Florida, Inc. ("Intermedia") shall file the original and ten copies of the following information with the Commission no later than 30 days from the date of this Order.

1. Does Intermedia have any affiliates? If yes, explain in detail and state whether any affiliate has ever been compensated for providing intrastate telecommunications services within the Commonwealth of Kentucky.

2. Briefly describe the extent and type of facilities which Intermedia owns or controls for providing facilities-based telecommunications services within Kentucky. Are any of the facilities located within the Commonwealth of Kentucky? If yes, fully describe the extent, type, and location of the facilities and the date they were implemented.

3. For the following items, refer to Intermedia's proposed tariff filed as Exhibit 5 to the application:

a. Refer to Original Page 7, Section 2.1.1(A). Pursuant to Administrative Case No. 338,¹ Intermedia should file rates and conditions of service for enhanced services or should file a petition pursuant to KRS 278.512 and KRS 278.514 setting forth the reasons why the service should be exempt from regulation or subject to alternative regulation.

b. Refer to Orginal Page 12, Section 2.4.6 File a new tariff page with the following modification: Replace the phrase "any and all" in the first sentence with the word "reasonable".

c. Refer to Original Page 15, Section 2.10, Late Payment Charge. File new tariff pages to comply with 807 KAR 5:006, Section 8(3)(h), which allows the penalty to be assessed only once on any bill for rendered services, requires any payment to first be applied to the bill for services rendered, and prohibits assessing additional penalty charges on unpaid penalty charges.

d. Refer to Orginal Page 15, Section 2.11, Returned Check Charges. File a new tariff page with the following modification: Remove ", or five percent of the amount of the check, whichever is greater," from the paragraph.

e. Pursuant to 807 KAR 5:006, Section 6(3), file new tariff pages which include the billing form, or its contents, in Intermedia's proposed tariff. To comply with 807 KAR 5:006, Section 13(1)(a), list in the bill format a toll-free number or method for accepting collect calls for customer inquiries.
