As an owner of property located within 500' of the tower, Kentucky CGSA, Inc. is proposing to construct, I would like to state my opposition to this project at this location for the following reasons:

1. Keeping in mind the expansion of downtown Louisville, as well as the Waterfront Project, this tower presents the "industrial" look in an area in which millions of dollars have been spent to relocate "industrial type" businesses to more suitable, less visible areas of the city.

2. There are many locations within one mile southeast of this I-65 location that will not be visible at all to the visitors or travelers passing through getting their first look at downtown Louisville after crossing into Kentucky from Indiana.

3. The area bounded by I-65 on the east, Jefferson Street on the south, Floyd Street on the west and Market Street on the north is currently being looked at for possible development of an upscale project. A tower adjacent to this area would definitely be out of context with the project in mind. (See attached sheet for location of site).
