O R D E R

On November 27, 1996, Kentucky Power Company, d/b/a American Electric Power ("Kentucky Power"), filed an application, pursuant to KRS 278.183, for approval of its environmental compliance plan and rate surcharge to recover its costs of environmental compliance. Kentucky Power proposes to make the surcharge effective on December 31, 1996.

After reviewing the application and being otherwise sufficiently advised, the Commission finds that further proceedings are necessary to determine the reasonableness and cost-effectiveness of the proposed environmental compliance plan and rate surcharge. Pursuant to KRS 278.183(2), the Commission has six months from the date the application is filed to conduct these further proceedings.

IT IS THEREFORE ORDERED that:

1. Kentucky Power's proposed rate surcharge is suspended through May 26, 1997.

2. The procedural schedule set forth in Appendix A to this Order shall be followed.

3. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 10 copies to the Commission.

4. Kentucky Power shall give notice of the hearing in accordance with 807 KAR 5:011, Section 8(5). At the time publication is requested, Kentucky Power shall forward a duplicate of the notice and request to the Commission.

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and shall be granted only upon a showing of good cause.


6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
