### ORDER

On December 2, 1996, North Hopkins Water District ("North Hopkins") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. North Hopkins purchases water from the City of Madisonville ("Madisonville").
- 2. Effective January 1, 1997, Madisonville will decrease its rates for wholesale water from \$1.85 per 1,000 gallons to \$1.82 per 1,000 gallons.
- 3. During the 12 months ending October 31, 1996, North Hopkins purchased 52,851,000 gallons of water and sold 47,939,000 gallons.
- 4. North Hopkins' calculations are correct and show a decrease in purchased water cost of \$1,585.53, resulting in a purchased water adjustment of 3 cents per 1,000

gallons. Based on an average monthly usage of 5,000 gallons, monthly bills to North Hopkins' customers will decrease from \$44.70 to \$44.55 or 3 percent.

5. The purchased water adjustment of 3 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of 3 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after January 1, 1997.
  - 2. North Hopkins' proposed tariff is approved.
- 3. Within 20 days of the date of this Order, North Hopkins shall file verification that the notice to its customers has been given.
