

It appears from the record of this proceeding, which is incorporated herein as if copied in its entirety, that such utility has not filed the required Annual and Gross Revenue Reports and has given no reason why it failed to file such Annual and Gross Revenue Reports. It thus appears from the record that the above-referenced utility has willfully failed to submit the subject report and willfully failed to comply with the applicable provisions of KRS Chapter 278 and should be assessed a penalty of \$250 for its willful failure to comply with the law.

IT IS THEREFORE ORDERED that:

1. Town and Country Water District is assessed a penalty of \$250 for its willful violation of KRS 278.230(3) and Administrative Regulation 807 KAR 5:006, Section 3(1).
2. Town and Country Water District shall pay the assessed penalty within 20 days of the date of this Order. Payment shall be made by certified check or money order made payable to "Treasurer, Commonwealth of Kentucky," and shall be delivered to the Office of General Counsel, Public Service Commission of Kentucky, 730 Schenkel Lane, P. O. Box 615, Frankfort, Kentucky 40602.
3. Within 20 days of the date of this Order, Town and Country Water District shall file with the Commission completed Annual and Gross Revenue Reports as required by law.
