O R D E R

On April 12, 1993, in Case No. 92-326, the Commission approved certain adjusted rates for Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), and provided for their further adjustment on a quarterly basis in accordance with its gas cost adjustment ("GCA") clause.

On October 2, 1997, Equitable filed its GCA to be effective November 1, 1997 through January 31, 1998.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice of October 2, 1997 proposed revised rates designed to pass on expected increased wholesale gas costs to its customers. Equitable's proposed expected gas cost ("EGC") is \$5.2906 per Mcf, which includes a surcharge component of 80.54 cents per Mcf relating to the settlement of Kentucky West Virginia Gas Company Docket No. TQ 89-1-46-000, et al. before the Federal Energy Regulatory Commission.

2. Equitable's notice of October 2, 1997 set out a current quarter actual adjustment ("AA") of 3.99 cents per Mcf to collect under-recovered gas cost from April, May, and June 1997. Equitable's total AA of 38.04 cents per Mcf reflects the current under-recovery as well as over- and under-recoveries from previous quarters.

3. Equitable's notice set out a current quarter balancing adjustment ("BA") of (7.76) cents per Mcf. Equitable's total BA is (.58) cent per Mcf.

4. These adjustments produce a revised gas cost recovery ("GCR") rate of \$5.6652 per Mcf, 37.50 cents per Mcf more than its prior GCR rate.

5. The rate adjustment in the Appendix to this Order is fair, just, and reasonable, in the public interest, and should be effective for final meter readings on and after November 1, 1997.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable and are effective for final meter readings on and after November 1, 1997.


2. Within 30 days of the date of this Order, Equitable shall file with this Commission its revised tariffs setting out the rates authorized herein.

The following rates and charges are prescribed for the customers in the area served by Equitable Gas Company. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the date of this Order.
