O R D E R

On September 29, 1995, in Case No. 95-010, the Commission approved adjusted rates for Western Kentucky Gas Company ("Western"), with their further adjustment to be made in accordance with the monthly gas cost adjustment ("GCA") approved in the final Order in Case No. 92-558.<sup>1</sup>

On October 31, 1997, Western filed its monthly GCA to be effective from December 1, 1997 to January 1, 1998.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Western's notice proposed revised rates designed to pass to its firm sales customers an expected wholesale increase in gas costs. Western's expected gas cost ("EGC") for firm sales customers is \$4.9941 per Mcf and \$4.2621 for high load factor ("HLF") firm customers.

Western also proposed to pass to its interruptible customers a wholesale increase in gas costs. Western's proposed EGC for interruptible sales customers is \$4.2621 per Mcf.

2. Western has no current supplier refunds to return to its customers. Total refund factors of 5.19 cents per Mcf for firm sales customers and 1.66 cents per Mcf for interruptible customers reflect adjustments from previous months.

Total refund adjustments for T-2 firm and T-2 interruptible transportation customers are 4.88 cents per Mcf and 1.35 cents per Mcf, respectively.

3. Western's notice set out the 6-month correction factor ("CF") of 12.11 cents per Mcf which will remain in effect until April 1, 1998. The CF is designed to collect net under-collections of gas cost from the 6-month period ending June 30, 1997.

4. These adjustments produce gas cost adjustments of \$1.6302 per Mcf for firm sales customers, \$.8982 per Mcf for HLF customers, and \$1.7153 per Mcf for interruptible sales customers.

5. The rate adjustments in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be effective for final meter readings on and after December 1, 1997.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable and are approved effective for final meter readings on and after December 1, 1997.

2. Within 30 days of the date of this Order, Western shall file with the Commission its revised tariffs setting out the rates authorized in this Order.

## APPENDIX

### APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 95-010-AA DATED DECEMBER 1, 1997

The following rates and charges are prescribed for the customers in the area served by Western Kentucky Gas Company. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

#### RATES:

Applicable to: General Sales Service Rate G-1

##### Gas Cost Adjustment

To each bill rendered under the above-named rate schedules there shall be added an amount equal to: \$1.6302 per Mcf of gas used during the billing period.

Applicable to: HLF General Sales Service

##### Gas Cost Adjustment

To each bill rendered under the above-named rate schedules there shall be added an amount equal to: \$.8982 per Mcf of gas used during the billing period.

Applicable to: Interruptible Sales Service Rate G-2

##### Gas Cost Adjustment

To each bill rendered under the above-named rate schedules there shall be added an amount equal to: \$1.7153 per Mcf of gas used during the billing period.
