a letter on December 13, 1996 that took 5 days to get thru the Xmas rush,  
Then you had the nerve to tack on a 20 day reply..Just good old politics...

Protest number three;  
We already know that we are wasting our time but we do want to register our  
protest & complaint...Furthermore I will complain to elected officials here  
in Metcalfe Co---I guess it would be fair to say my wounds not fully healed  
from the screwing that the Cumberland Parkway gave us dome 25 years ago. They  
wrecked my farm by splitting right down the middle, sestroyed my big spring,  
A gas-oil well I had cased...took 17 acres of the best land I had then built  
a mountain in my front door---That is your Eminent Domain law, more to come.  
Other farmers just lost a corner, some a small slab...Some got bridges, tunnels  
and viaducts to move their cattle back & forth. Me for the last 25 years I  
have had to hire trucks, trailers and once two cowboys with horses to to  
transport my cattle four or five times each & every year.across Parkway..

About 2 years ago another Telephone or Cellular built a similar  
tower about 2 miles East of us for the same purpose. That old woman that  
sold the land for \$25,000.00 only got \$5,000.00 Some said they blindfolded  
her, anyway she lost a sweet \$20,000.00.....That company showed more respect  
to our community than you people, they installed their tower in a remote area  
no traffic, disturbed nor robbed none of the neighbors.....You people dont  
care who you hurt or damage...same applies to the sellers couldnt care less  
for they are very wealthy. Other neighbors not effected or hurt because  
they have no highway frontage and I am only about 400 ft. away from this  
monster with many,many guidewires running from the top to the bottom some  
calls them icicles along with many, many flashing lights. Could I call it  
a big Christmas trees playing Santa Claus 365 days a year. At my age 67  
I plan to cease farming this year & divide, sell that side with highway  
frontage in building lots.....This will reall hurt my land sale.
