O R D E R

The Commission, on its own motion, HEREBY ORDERS that:

4. South Williamson Real Estate shall give notice of the hearing by mail to each customer in accordance with KRS 424.300 and 807 KAR 5:011, Section 8(5). At the time notice is mailed, the Applicant shall forward to the Commission a duplicate of the notice and the name and address of each customer so notified.

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
