O R D E R

On February 21, 1997, Cellular Information Systems of Florence, Inc. ("Cellular Information") filed an application seeking a Certificate of Public Convenience and Necessity to build and operate a cellular radio telecommunications facility for Rural Service Area No. 6 ("RSA No. 6"). RSA No. 6 includes Boyle, Casey, Garrard, Laurel, Lincoln, Madison, Pulaski, and Rockcastle counties. Cellular Information has requested authorization to construct a cell site in Madison County. Cellular Information was previously granted authority to operate a cellular radio telecommunications system in RSA No. 6 in Case No. 96-491.<sup>1</sup>

The proposed cell site consists of a 280-foot or less self-supporting antenna tower to be located at 850 South Dogwood Drive, Berea, Madison County, Kentucky ("the Berea cell site"). The coordinates for the Berea cell site are North Latitude 37° 32' 51" by West Longitude 84° 19' 59".

Cellular Information has provided information regarding the structure of the tower, safety measures, and antenna design criteria for the Berea cell site. Based upon the application, the design of the tower and foundation conforms to applicable nationally recognized building standards, and the plans have been certified by a Registered Professional Engineer.

Pursuant to KRS 100.324(1), the Berea cell site's construction is exempt from local zoning ordinances; however, Cellular Information notified the Madison County Judge/Executive of the pending construction. Cellular Information has filed applications with the Federal Aviation Administration ("FAA") and the Kentucky Airport Zoning Commission ("KAZC") seeking approval for the construction and operation of the Berea cell site. Both applications are pending.

Cellular Information has filed notices verifying that each person who owns property or who resides within 500 feet of the Berea cell site has been notified of the pending construction. The notice solicited any comments and informed the property owners or residents of their right to intervene. In addition, notice was posted in a visible location on the proposed site for at least two weeks after Cellular Information's application was filed. To date, no intervention requests have been received.

Pursuant to KRS 278.280, the Commission is required to determine proper practices to be observed when it finds, upon complaint or on its own motion, that the facilities of any

utility subject to its jurisdiction are unreasonable, unsafe, improper, or insufficient. To assist the Commission in its efforts to comply with this mandate, Cellular Information should notify the Commission if it does not use this antenna tower to provide cellular radio telecommunications services in the manner set out in its application and this Order. Upon receipt of such notice, the Commission may, on its own motion, institute proceedings to consider the proper practices, including removal of the unused antenna tower, which should be observed by Cellular Information.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that Cellular Information should be granted a Certificate of Public Convenience and Necessity to construct and operate the Berea cell site in RSA No. 6 under its previously approved tariff.

IT IS THEREFORE ORDERED that:

1. Cellular Information is granted a Certificate of Public Convenience and Necessity to construct and operate the Berea cell site.
2. Cellular Information shall file a copy of the final decisions regarding the pending FAA and KAZC applications for the Berea cell sites construction within 10 days of receiving these decisions.
3. Cellular Information shall immediately notify the Commission in writing, if, after the antenna tower is built and utility service is commenced, the tower is not used for a period of 3 months in the manner authorized by this Order.
