O R D E R

On September 11, 1997, Louisville Gas and Electric Company ("LG&E") and members of its Demand-Side Management Collaborative ("Collaborative") filed a joint motion requesting that: 1) the public hearing scheduled for October 10, 1997 be rescheduled, and 2) the Commission schedule an informal conference between LG&E, the Collaborative, and the Commission Staff. In support of the request, LG&E and the Collaborative indicated there was a conflict with the October 10, 1997 date. In addition, LG&E and the Collaborative expressed the belief that an informal conference would assist the Commission and the parties with regard to the issues to be addressed in this proceeding.

The Commission finds that good cause exists to grant both requests. In addition, the Commission believes it would be beneficial if LG&E would provide a proposed agenda prior to the informal conference, which would clearly identify the subjects LG&E and the Collaborative wish to discuss.

IT IS THEREFORE ORDERED that the procedural schedule appended to the Commission's August 4, 1997 Order is modified as provided for in the procedural schedule attached hereto as Appendix A.
