## ORDER

On May 1, 1997, AT&T Wireless PCS, Inc. ("AT&T Wireless") filed an application with the Commission requesting a Certificate of Public Convenience and Necessity to construct and operate a cellular facility at 1654 Petersburg Road, Hebron, Boone County, Kentucky.

The Boone County Planning Commission ("Planning Commission") has moved for full intervention and for a public hearing. The Commission finds that the Planning Commission has a special interest in this matter which is not otherwise adequately represented, and that its intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Accordingly, the Planning Commission's motion to intervene should be granted. In addition, the Commission has scheduled a hearing on the proposed cellular facility for July 24, 1997, at 10:00 a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 730 Schenkel Lane, Frankfort, Kentucky.

IT IS THEREFORE ORDERED that:

1. The motion of the Planning Commission to intervene is granted, and it shall be

entitled to the full rights of a party and shall be served with the Commission's Orders and

with filed testimony, exhibits, pleadings, correspondence, and all other documents

submitted by parties after the date of this Order.

2. Should the Planning Commission file documents of any kind with the

Commission in the course of these proceedings, it shall also serve a copy of said

documents on all other parties of record.

3. A hearing on the proposed cell site is scheduled for July 24, 1997, at 10:00

a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 730

Schenkel Lane, Frankfort, Kentucky.

4. AT&T Wireless shall appear at the hearing and be prepared to present

testimony on the engineering design, location, and construction of the proposed cell site,

as well as the safety issues relating to the cell site.

5. Any interested person shall have the opportunity to present testimony or

comment on any aspect of the proposed cell site.

6. Prefiled testimony, if any, shall be filed by July 17, 1997.
