ORDER

On October 10, 1990, in Case No. 90-002, the Commission approved certain adjusted rates for East Kentucky Utilities, Inc. ("East Kentucky") and provided for their further adjustment when the wholesale cost of gas changes or a refund is received.

On March 12, 1998, East Kentucky notified the Commission that its wholesale cost of gas will be increased by its supplier effective November 1, 1998, and submitted with its notice information required by its purchased gas adjustment ("PGA") clause.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. East Kentucky's notice proposes revised rates designed to pass on its increased wholesale gas cost in the amount of 13.75 cents per Dth, or 18.04 cents per Mcf.
2. East Kentucky's contract with Equitable Resources Marketing Company contains a pricing provision which increases East Kentucky's cost of gas from \$2.75 per Dth to \$2.8875 per Dth effective November 1, 1998.

3. East Kentucky's adjustment in rates is fair, just and reasonable, in the public interest, and should be effective for gas supplied on and after November 1, 1998.


IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable, and are approved effective for gas supplied on and after November 1, 1998.


2. Within 30 days of the date of this Order, East Kentucky shall file with this Commission its revised tariffs setting out the rates authorized herein.



APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 90-002-BB DATED OCTOBER 21, 1998

The following rates and charges are prescribed for the customers in the area served by East Kentucky Utilities, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

RATES: Monthly

First Mcf	\$9.5187
All Over 1 Mcf	6.5638
Minimum Bill	\$9.52

A surcharge in the amount of \$.8048 per Mcf will be added to the above rates until the obligation owed to Kentucky West Virginia Gas Company has been discharged or is recalculated.

The base rate for the future application of the purchased gas adjustment clause of East Kentucky Utilities, Inc. shall be:
