ORDER

Meade County Rural Electric Cooperative Corporation ("Meade County") has moved for the Commission to amend its Order of June 15, 1998 to permit Meade County to continue charging its residential customers the flat rate charges set forth in the Commission's Order of May 6, 1998 prior to the closing of the lease transaction between Big Rivers Electric Corporation and LG&E Energy Corporation.

Having considered the motion and being otherwise sufficiently advised, the Commission finds that the motion should be granted. Meade County has been charging the flat rate charges since on and after April 30, 1998. To return to the pre-April 30, 1998 charges will result in customer confusion and in administrative inconvenience for the utility. Since the flat rate charges produce the same level of revenue as the pre-April 30, 1998 rates, neither the utility nor any customer class will be prejudiced by continued use of the flat rate charges.

IT IS THEREFORE ORDERED that:

- 1. Meade County's Motion to Amend is granted.
- 2. Meade County shall charge to residential customers the rates set forth in Appendix A to this Order.

3. All provisions of the May 6, 1998 and June 15, 1998 Orders not amended herein shall remain in full force and effect.
