O R D E R

Having reviewed the responses of Montgomery County Water District No. 1 ("Montgomery District") to the Commission's Order of October 1, 1997, the Commission finds that further proceedings are required. By this Order, the Commission establishes a procedural schedule for those proceedings.

IT IS HEREBY ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed. If none of the parties file written objections to the positions contained in Commission Staff's testimony, the procedural schedule will be vacated and the Commission will proceed to enter a decision in this matter based solely upon the existing record.
2. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 10 copies to the Commission.
3. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

4. For purposes of this Order, the service of any document upon another party shall be made by delivering a copy to its attorney of record or by mailing it to him at his address of record. Delivery of a copy means handing it to the attorney or leaving it at his office with the person in charge thereof. Service by mail is complete upon mailing.

5. To be timely filed with the Commission, a document must be received by the Secretary of the Commission within the specified time for filing except that any document shall be deemed timely filed if it has been transmitted by United States express mail, or by other recognized mail carriers, with the date of the transmitting agency received said document from the sender noted by the transmitting agency on the outside of the container used for transmitting, within the time allowed for filing.

6. The record of Case No. 96-118¹ is incorporated by reference into the record of this proceeding.


7. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.

O R D E R

IT IS ORDERED that East Kentucky Power Cooperative, Inc. ("EKPC") shall file, within 20 days of the date of this Order, the original and 5 copies of the following information with the Commission. The requested information shall be placed in a bound volume with each item tabbed. When a response requires multiple pages, each page should be indexed appropriately, for example, Item 1(a), page 2 of 4. With each response, include the name of the witness who will be responsible for responding to questions related thereto. Careful attention should be given to copied material to ensure its legibility.

1. List each written coal supply solicitation issued during the period from November 1, 1997 to April 30, 1998.

a. For each solicitation, provide the date of the solicitation, the type of solicitation (contract or spot), the quantities solicited, a general description of the quality of coal solicited, the time period over which deliveries were requested, and the generating unit(s) for which the coal was intended.

b. For each solicitation, state the number of vendors to whom the solicitation was sent, the number of vendors who responded, and the selected vendor.

Provide the bid tabulation sheet or corresponding document that ranked the proposals. (This document should identify all vendors who made offers.) State the reasons for each selection.

2. List each oral coal supply solicitation issued during the period from November 1, 1997 to April 30, 1998.

a. For each solicitation, state why the solicitation was not written, the date(s) of the solicitation, the quantities solicited, a general description of the quality of coal solicited, the time period over which deliveries were requested, and the generating unit(s) for which the coal was intended.

b. For each solicitation, identify all vendors solicited and the vendor selected. Provide the tabulation sheet or other document that ranks the proposals. (This document should identify all vendors who made offers.) State the reasons for each selection.

3. Refer to EKPC's response to the Commission's Order of June 17, 1998, Item 1. State the number of solicitations issued to each vendor listed in EKPC's response, identified as contract or spot solicitations, and the number of proposals made by each vendor in response to the solicitations.

4. a. During the period under review, did EKPC amend its Open Access Transmission Tariff on file with the Federal Energy Regulatory Commission?

b. If yes, describe the amendments and provide the revised tariff sheets.
