O R D E R

On November 4, 1998, Bracken County Water District ("Bracken County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Bracken County purchases its water from the City of Augusta ("Augusta").
2. Augusta increased the wholesale water rate charged to Bracken County from \$.65 per 1,000 gallons to \$1.09 per 1,000 gallons purchased effective October 28, 1998.
3. During the 12 months ending August 31, 1998, Bracken County purchased 146,763,400 gallons of water and sold 132,851,800 gallons.
4. The increase in the cost of purchased water is \$64,576 resulting in a purchased water adjustment of 49 cents per 1,000 gallons of water. Based on a monthly usage of 5,000 gallons, the average bill of a Bracken County customer, not including any surcharge, would increase \$2.45 from \$15.30 to \$17.75, or 16 percent.

5. The calculations and proposed tariff provided by Bracken County are correct and should be approved.

6. The purchased water adjustment of 49 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of 49 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after November 1, 1998.


2. The tariff submitted by Bracken County is hereby approved as filed.


3. Within 20 days from the effective date of this Order, Bracken County shall file a copy of the notice to its customers and verification that such notice has been given.


