ORDER

On April 6, 1992, in Case No. 92-407, the Commission approved certain rates for Valley Gas, Inc. ("Valley") and provided by tariff for their further adjustment on a quarterly basis in accordance with Valley's Gas Cost Adjustment ("GCA") clause.

On December 1, 2000, Valley filed its GCA to be effective from January 1, 2001 through March 31, 2001.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Valley's notice proposed revised rates designed to pass on expected increased wholesale gas costs to its customers. Valley's proposed expected gas supply cost is \$7.4753 per Mcf, which is \$1.4697 per Mcf more than the previous expected gas supply cost of \$6.0056.
2. Valley has no current supplier refunds to return to its customers.
3. Valley's notice set out a current quarter actual adjustment ("AA") of 40.83 cents per Mcf to collect under-recovered gas cost from May 1997 through June 2000. The proposed total AA is also 40.83 cents per Mcf and represents no increase from the prior period. Valley's AA will remain in effect for 24 months.

4. Valley's notice set out no Balance Adjustment ("BA"). This represents no change from the prior quarter.

5. These adjustments produce a gas cost adjustment of \$7.8836 per Mcf, \$1.4697 per Mcf more than the prior gas cost adjustment of \$6.4139 per Mcf.

The rate adjustment in the Appendix to this Order is fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after January 1, 2001.

IT IS THEREFORE ORDERED that:

1. The rate in the Appendix to this Order is fair, just, and reasonable and is effective for gas supplied on and after January 1, 2001.

2. Within 30 days of the date of this Order, Valley shall file with this Commission its revised tariffs setting out the rates authorized in this Order.
