O R D E R

On October 27, 1998, in Case No. 98-244, the Commission approved certain rates for Sigma Gas Corporation ("Sigma") and provided for their further adjustment on a quarterly basis in accordance with Sigma's approved gas cost adjustment ("GCA") clause.

On February 28, 2000, Sigma filed its GCA to be effective April 1, 2000 through June 30, 2000.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. In its notice of February 28, 2000 Sigma proposed revised rates designed to pass on to its customers its expected wholesale decrease in gas costs. Sigma's proposed EGC is \$3.7180 per Mcf, 22 cents per Mcf less than the prior EGC.
2. Sigma's notice set out no current refund adjustment.
3. Sigma's notice set out a current quarter actual adjustment ("AA") of 14.4 cents per Mcf to collect under-recovered gas cost from October, November, and December 1999. The total AA of .5 cent per Mcf is composed of the current AA and previous quarter AAs, and represents an increase of 14.36 cents per Mcf from the prior total AA.

4. Sigma's notice proposed a current quarter balance adjustment ("BA") of .3 cent per Mcf to reconcile a remaining under-recovery. The total BA of 3.44 cents per Mcf represents an increase of .3 cent per Mcf from the prior total BA.

5. Sigma's gas cost recovery rate is \$3.7574 per Mcf, 7.34 cents per Mcf less than the previously authorized rate of \$3.8308 per Mcf.

6. Sigma's adjustment in rates contained in the Appendix to this Order is fair, just, and reasonable, in the public interest, and should be approved effective with bills rendered on and after April 1, 2000.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable, and are authorized to be effective with bills rendered on and after April 1, 2000.

2. Within 30 days of the date of this Order, Sigma shall file with this Commission its revised tariffs setting out the rates approved herein.
