O R D E R

The Commission, on its own motion, HEREBY ORDERS that:

1. The procedural schedule listed in Appendix A, which is attached hereto and incorporated herein, shall be followed. At the public hearing, there shall be no opening statements and no summaries of testimony.
2. Any party filing testimony shall file an original and 12 copies. The original and at least three copies of the testimony shall be filed as follows:
  - a. Together with cover letter listing each person presenting testimony.
  - b. Bound in 3-ring binders or with any other fastener which readily opens and closes to facilitate easy copying.
  - c. Each witness's testimony should be tabbed.
  - d. Every exhibit to each witness's testimony should be appropriately marked.

3. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and an original and six copies to the Commission.

4. East Kentucky Power Cooperative, Inc. ("East Kentucky") shall give notice of the hearing in the counties of Clark, Estill, Madison, and Powell in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, East Kentucky shall forward to the Commission a duplicate of the notice and request.

5. Nothing contained herein shall prevent the Commission from entering further orders in this matter.
