All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and an original and 10 copies to the Commission.

4. PowerGen, plc ("PowerGen"), Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, the Applicants shall forward a duplicate of the notice and request to the Commission.

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.
