ORDER

Kentucky-American Water Company (“Kentucky-American”) has applied for approval to adjust its rates for water service. Finding that further proceedings were necessary to investigate the reasonableness of the proposed rates, the Commission by this Order suspends the operation of the proposed rates for a period of six months.

IT IS THEREFORE ORDERED that:

1. The proposed rates set forth in Kentucky-American’s application are suspended up to and including November 28, 2000.
2. The procedural schedule set forth in the Appendix to this Order shall be followed.
3. All documents filed with the Commission shall comply with the provisions of the Commission’s Order of April 24, 2000.
4. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 4 paper copies and 1 electronic copy to the Commission.

5. Kentucky-American shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, it shall forward a duplicate of the notice and request to the Commission.

6. At any hearing in this matter, neither opening statements nor summarization of direct testimony shall be permitted.

7. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

8. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.

- Intervenor testimony, if any, shall be filed with the Commission in verified prepared form no later than 07/28/2000
- All requests for information to any Intervenor shall be served upon that Intervenor no later than..... 08/11/2000
- Intervenors shall file with the Commission and serve upon all parties of record their responses to the requests for information no later than 08/25/2000
- Kentucky-American may file with the Commission the testimony of its rebuttal witnesses in written verified form no later than 09/08/2000
- Last day for Kentucky-American to publish notice of hearing date 09/12/2000
- Public Hearing is to begin at 9:00 a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of cross-examination of witnesses of Kentucky-American and the Intervenors 09/19/2000
- Parties may file written briefs with the Commission no later than 10/20/2000
