ALLEGED VIOLATION(S) OF KRS 278.535 SWITCHING OF TELECOMMUNICATIONS PROVIDER

America's Tele-Network Corporation ("America's Tele-Network") is a communications provider as defined in KRS 278.535(1)(a), is authorized to do business in Kentucky, and is subject to the Commission's jurisdiction. America's Tele-Network is a foreign corporation (identification number 0416487) authorized by the Office of the Secretary of State of the Commonwealth of Kentucky to do business in Kentucky as of May 22, 1995. The records maintained by the Office of Secretary of State show that the principal place of business for America's Tele-Network is 720 Hembree Place, Alphretta, Georgia 30076 and show that the registered agent is CSC Corporation Service Co., 421 West Main Street, Frankfort, Kentucky 40601.

KRS 278.535(1)(a) prescribes statutory procedures for the proper changing of any Kentucky customer's primary telecommunications carrier.

COUNT I

1. On or about January 21, 2000, Derek Anderson reported to Commission Staff by telephone that his long-distance carrier had been changed to America's Tele-Network without his authority or permission. Mr. Anderson's telephone number is 606/278-2241.

2. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Mr. Anderson by which he properly authorized the carrier change.

<u>COUNT II</u>

1. On or about October 14, 1999, Richard Austin reported to Commission Staff by telephone that his long-distance carrier had been changed from AT&T to Sprint without his authority or permission. Mr. Austin's telephone number is 502/543-6120.

2. By letter dated October 14, 1999, Commission Staff notified Sprint of Mr. Austin's Complaint. The letter requested that Sprint provide Commission Staff appropriate evidence that Mr. Austin had authorized the carrier change. A copy of said letter is attached hereto and marked **Appendix Count II-A**.

3. Sprint responded by letter on October 27, 1999 to the Commission's letter dated October 14, 1999. In the response letter, Sprint replied that it had no record of Mr. Austin in its system, but that the number was located on the account of America's Tele-Network. America's Tele-Network is a reseller of Sprint services. A copy of said letter is attached hereto and marked **Appendix Count II-B**.

4. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Mr. Austin by which he properly authorized the carrier change to America's Tele-Network. KRS 278.535(2) places the burden of proof on America's Tele-Network to show that Mr. Austin knowingly authorized the carrier change.

COUNT III

1. On or about January 25, 2000, Kevin Botner reported to Commission Staff by telephone that his long-distance carrier had been changed from MCI to America's Tele-Network without his authority or permission. Mr. Botner's telephone number is 502/231-0231.

2. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Mr. Botner by which he properly authorized the carrier change.

<u>COUNT IV</u>

1. On or about January 26, 2000, Cheryl Bowman reported to Commission Staff by telephone that her long-distance carrier had been changed to America's Tele-Network without her authority or permission. Ms. Bowman's telephone number is 606/985-0674.

2. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Ms. Bowman by which she properly authorized the carrier change.

COUNT V

1. On or about January 24, 2000, James Brown reported to Commission Staff by telephone that his long-distance carrier had been changed from AT&T to Sprint without his authority or permission. Mr. Brown's telephone number is 606/986-3960.

2. By letter dated February 4, 2000, Commission Staff notified Sprint of Mr. Brown's complaint. The letter requested that Sprint provide Commission Staff appropriate evidence that Mr. Brown had authorized the carrier change. A copy of said letter is attached hereto and marked **Appendix Count V-A**.

3. Sprint responded by letter on February 15, 2000 to the Commission's letter dated February 4, 2000. In the response letter, Sprint replied that it had no record of Mr. Brown in its system, but that the number was located on the account of America's Tele-Network. America's Tele-Network is a reseller of Sprint services. A copy of said letter is attached hereto and marked **Appendix Count V-B**

4. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Mr. Brown by which he properly authorized the carrier change to America's Tele-Network. KRS 278.535(2) places the burden of proof on America's Tele-Network to show that Mr. Brown knowingly authorized the carrier change.

<u>COUNT VI</u>

1. On or about January 5, 2000, R.L. Bumgardner reported to Commission Staff by telephone that his long-distance carrier had been changed from Sprint to

America's Tele-Network without his authority or permission. Mr. Bumgardner's telephone number is 606/873-4924.

2. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Mr. Bumgardner by which he properly authorized the carrier change.

<u>COUNT VII</u>

1. On or about February 11, 2000, Nancy Byers reported to Commission Staff by telephone that her long-distance carrier had been changed from GTE Long Distance to America's Tele-Network without her authority or permission. Ms. Byers's telephone number is 606/254-6559.

2. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Ms. Byers by which she properly authorized the carrier change.

America's Tele-Network is a reseller of Sprint services. A copy of said letter is attached hereto and marked **Appendix Count IX-B**

4. After investigation, Commission Staff has been unable to obtain or secure any written authorization or electronically recorded authorization of Mr. Conrad by which he properly authorized the carrier change to America's Tele-Network. KRS 278.535(2) places the burden of proof on America's Tele-Network to show that Mr. Conrad knowingly authorized the carrier change.

<u>COUNT X</u>

1. On or about February 7, 2000, Dorothy Coffee reported to Commission Staff by telephone that her long-distance carrier had been changed to America's Tele-

Based on the foregoing allegations and on the results of the investigations by the Commission Staff, the Commission, on its own motion, HEREBY ORDERS that:

1. America's Tele-Network shall submit to the Commission within 30 days of the date of receipt of this Order a response to the allegations contained in each Count above.

2. America's Tele-Network shall appear on September 5, 2000 at 10:00 a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky for the purpose of showing cause why it should not be subject to penalties pursuant to KRS 278.990(1) and KRS 278.535(6) for the alleged violations of law described herein.

3. Any request for an informal conference with the Commission Staff to consider any matter which would expedite the handling or disposition of this proceeding shall be filed with the Commission no later than 30 days from the date of receipt of this Order.
