ORDER

On August 29, 2000, Blue Grass Energy Cooperative Corporation ("Blue Grass") tendered for filing an application requesting an adjustment in its recurring CATV attachment rates and certain non-recurring miscellaneous charges. A review of the application and the Commission's filing requirements reveals a deficiency under 807 KAR 5:001, Section 10(4), by not stating the method used to notify customers of the proposed rate changes and not stating the dates of customer notification. In addition, the Commission notes that the application has not been signed by an attorney licensed to practice law within the Commonwealth of Kentucky. Since Blue Grass is a corporation and the filing of an application with this Commission constitutes the practice of law, Blue Grass must be represented by an attorney to proceed with this application.

Blue Grass has also requested the Commission to waive numerous filing requirements applicable to applications to adjust recurring rates. Under the circumstances of this case, the Commission finds good cause to grant waivers to the following filing requirements under 807 KAR 5:001, Section 10: (1)(b)5--Certificate of Corporate Good Standing; (2)--Four Weeks Advance Notice of Filing; (6)(b) &

(c)--Prepared Testimony; (6)(e)--Effect of Proposed Change on Average Bill of Each

Customer Classification; (6)(g)--Billing Analysis; (6)(h)--Summary Determination of

Revenue Requirements; (6)(i)--Reconciliation of Rate Base and Capital; (6)(j)--Current

Chart of Accounts; (6)(k)--Independent Auditor's Annual Report; (6)(n)--Summary of

Latest Appreciation Study; (6)(q)--Annual Report to Members; (6)(r)--Monthly

Managerial Reports; (6)(t)--Details of Affiliate Allocated Charges; (6)(u)--Cost-of-Service

Studies; (7)(b)--Capital Construction Budget; (7)(d)--Monthly Operating Budgets; and

(7)(e)--Test Year Customer Growth and Revenue Impact.

IT IS THEREFORE ORDERED that:

1. Within 10 days of the date of this Order, Blue Grass shall cure the filing

deficiency under 807 KAR 5:001, Section 10(4), and shall have its attorney file a notice

of entry of appearance.

2. The request for waivers of the filing requirements enumerated above is

granted.
