O R D E R

The Commission, on its own motion, HEREBY ORDERS that:

1. The procedural schedule set forth in Appendix A shall be followed.
2. Blue Grass Energy Cooperative Corporation (“Blue Grass”) shall appear at a public hearing at the Commission’s offices on the date set forth in Appendix A. At the public hearing, there shall be no opening statements and no summaries of testimony.
3. Blue Grass shall give notice of the hearing in accordance with the provisions of 807 KAR 5:011, Section 8(5). At the time publication is requested, Blue Grass shall forward a duplicate of the notice and request to the Commission.
4. Blue Grass and any intervenor shall file the information requested by Commission Staff by the dates set forth in Appendix A.
5. Any party filing testimony shall file an original and six copies. The original and at least three copies of the testimony shall be filed as follows:
 - a. Together with cover letter listing each person presenting testimony.
 - b. Bound in 3-ring binders or with any other fastener which readily opens and closes to facilitate easy copying.

c. Each witness's testimony should be tabbed.

d. Every exhibit to each witness's testimony should be appropriately marked.

6. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to questions related to the information, with copies to all parties of record and an original and six copies to the Commission.

7. Nothing contained herein shall prevent the Commission from entering further orders in this matter.
