O R D E R

The Commission, on its own motion, has determined that market forces are not having the desired effect on operator services rates. Specifically, while competitors continue to enter the market, prices continue to escalate. Price increases of 40 percent or more in surcharges and per minute transport rates are not unusual. While companies claim that one of the reasons for these increases is the need to cover costs, cost studies to support this position do not exist. Also, while competitive alternatives in the form of wireless services and prepaid cards do exist, a large portion of the population finds itself unable to use these alternatives. The provision of operator services still exhibits strong characteristics of a monopoly service. Therefore, it is in the public interest that all operator-assisted and automated calls from any location shall be capped at the rates approved for AT&T of the South Central States, Inc. in its February 4, 2000 tariff, attached hereto and incorporated herein. These maximum rates include both the operator service surcharge and the per minute transport rate. These rates shall remain capped until such time as market forces have the desired effect on existing rates. If at any time during this rate cap, a utility can demonstrate to the Commission

that its operator service surcharge and per minute transport rates do not cover its Kentucky costs, the Commission will consider amending this decision.

Accordingly, it is HEREBY ORDERED that:

1. This Order shall be effective 30 days from the date it is entered.
2. Within 20 days of the date of this Order, all providers of operator services as described herein whose rates exceed the maximum rates shall file necessary tariff revisions to be effective 30 days from the date of this Order.
3. A copy of this Order shall be served on all telecommunications carriers serving Kentucky.
