<u>ORDER</u>

On March 31, 2000, the Commission issued its Order in Case No. 99-225 approving certain adjustments to the rates of Citipower, LLC ("Citipower") and providing under certain conditions for the further adjustment of such rates in accordance with the provisions of Citipower's gas cost adjustment ("GCA") clause.

On December 21, 2000, Citipower filed its GCA to be effective January 1, 2001. This is Citipower's first GCA filing.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Citipower's notice proposed revised rates to pass on its expected increase in gas costs to its customers. Citipower's proposed expected gas cost ("EGC") is \$7.3671 per Mcf, an increase of \$5.3263 per Mcf from the prior EGC of \$2.0408.
 - 2. Citipower's notice set out no refund adjustment.
- 3. Citipower's notice set out an actual adjustment ("AA") of 15.51 cents per Mcf to collect under-recovered gas costs from July, August and September 2000. Since Citipower has not filed a GCA prior to this filing, the total AA is also 15.51 cents per Mcf.

4. Citipower's notice set out no balance adjustment.

5. These combined adjustments produce a gas cost adjustment of \$7.5222

per Mcf, \$5.4814 per Mcf more than the prior rate of \$2.0408.

6. The revised rates in the Appendix to this Order are fair, just, and

reasonable, in the public interest, and should be approved for service rendered on and

after January 20, 2001. Citipower did not give sufficient notice for the rates to be

effective January 1, 2001.

IT IS THEREFORE ORDERED that:

1. Citipower's proposed rates are approved.

2. The rates in the Appendix to this Order are fair, just, and reasonable, and

are effective for service rendered on and after January 20, 2001.

3. Within 30 days of the date of this Order, Citipower shall file with this

Commission its revised tariffs setting out the rates authorized herein.
