O R D E R

Pursuant to Commission Regulation 807 KAR 5:056, the Commission on December 12, 2000 established this case to review and evaluate the operation of the fuel adjustment clause ("FAC") of Big Sandy Rural Electric Cooperative Corporation ("Big Sandy") for the two years ended October 31, 2000.

As part of this review, the Commission ordered Big Sandy to submit certain information and an affidavit attesting to its compliance with Commission Regulation 807 KAR 5:056. Big Sandy has complied with this Order. The Commission further ordered that a public hearing be held in this case but cancelled it when, after publication of notice, no interested party advised the Commission of its intention to attend.


The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that Big Sandy has properly calculated and applied its FAC charge.

IT IS THEREFORE ORDERED that the charges and credits applied by Big Sandy through the FAC for the period November 1, 1998 to October 31, 2000 are approved.
